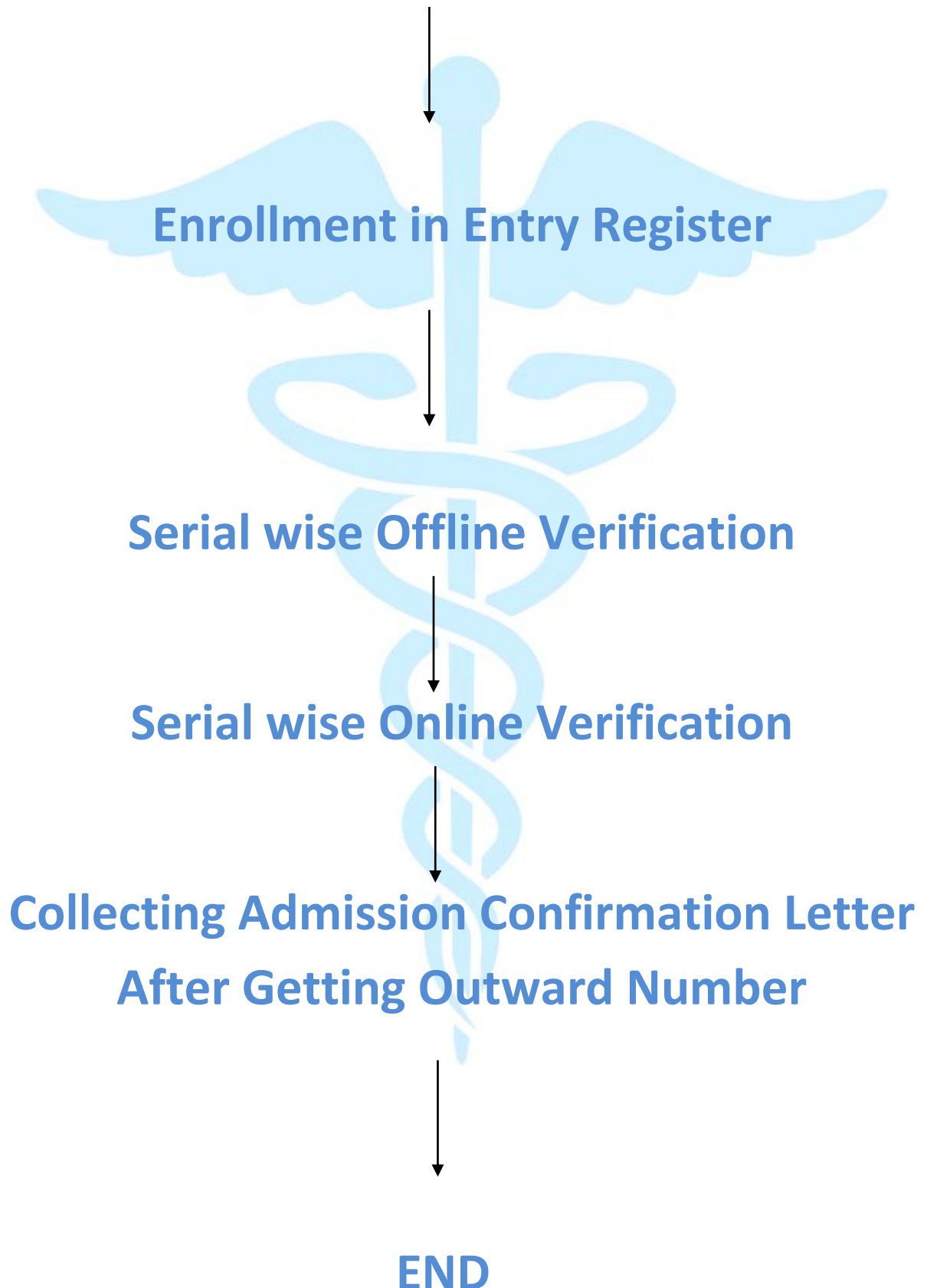

As per G.R. No.MED-1003/CR 641/03/Edu-2, dated 16/3/2004, 3% seats at Govt. / Municipal Corporation Medical colleges are reserved for the candidates from Hilly areas.

In accordance with G.R. issued by the Govt. of Maharashtra MED Dept. G.R. No. MED-1002/3852/CR-617/02/Edu-2, dated 17/4/2003 and resolutions issued by Govt. of Maharashtra from time to time, the candidates claiming seat under HA claim should satisfy following criteria to be eligible:

- i) **Domicile Certificate of the parent stating that he/she is domicile in the village declared as a Hilly area specified in the Table for the respective Regions** (Rest of Maharashtra/Vidarbha /Marathwada, As per the latest list issued by concerned Department) The said certificate should be obtained from the concerned Revenue Department officer (Tehsildar and Above).
- ii) To avail the benefit of HA claim, the candidate must have appeared at NEET UG -2025 examination.
- iii) The Competent Authority shall select the candidates claiming HA, on the basis of their Merit at NEET UG -2025 examination.
- iv) The constitutional reservation is provided under these HA claim seats.
- v) **The candidate should pass SSC/HSC (or equivalent) examination from School/Junior College situated in the hilly area of his/her parents domicile or if not so, at the most, from a School/Junior College situated in the taluka of his/her parent's domicile.**

1) DEFENCE CATEGORIES

- Def1 - For a son/daughter/spouse of an Ex-defence service personnel, domiciled in the state of Maharashtra.
- Def2 - For a son/daughter/spouse of Active defence service personnel domiciled in the state of Maharashtra.
- Def3 - For a son/daughter/spouse of Active defence service personnel, transferred to Maharashtra State from out-side Maharashtra, who is domicile of State other than Maharashtra.

2) For selection against Def-1 & Def-2 seats following conditions will apply;

- To be eligible for such a seat, a candidate must be a son/daughter/spouse of a person who has been a member of the Armed Forces of India and who has put in at least 5 years' active service and has been subject to Indian Army Act, Indian Navy Act or Indian Air Force Act; and includes an ex-serviceman who has retired from such service or was permanently disabled/killed in action. - Candidates belonging Def-1 & Def-2 category shall be considered eligible for admission even if they have passed SSC and /or HSC examination from outside Maharashtra State.

3) For selection against Def.-3 category following conditions shall apply:-

- The concerned Defence Service person who is domicile of the State other than Maharashtra and who has been transferred in public interest to Maharashtra State, prior to the last date for filling up of Preference Form.

- The candidate ought to have appeared and passed the qualifying examination.
- The candidate is required to attach necessary and sufficient proof to fulfill above conditions and a certificate in proforma issued by appropriate authority who is authorized to issue such certificate.

- 17.1 Failure of the candidate in making full and correct statements in the application form and/or suppression of any information would lead to disqualification of the candidate, even at later date. Such a candidate will be debarred from the entire selection process.
- 17.2 It is responsibility of every candidate to submit proper documents. Any attempt to submit documents which are not genuine will lead to cancellation of the admission of the candidate, forfeiture of the fees, deposits and expulsion of the candidate from the college by the Competent Authority or by his authorised official. The name of such candidate/s shall be deleted from the State Merit List and he/she will not be eligible for further rounds of the selection process and will be debarred from the selection process. If deemed fit even criminal proceeding may be initiated by the Competent Authority against such candidates / their parents.

If any candidate / authorised representative or person accompanying is found obstructing the counseling and / or admission process, or trying to influence in unlawful manner/ creating nuisance, the candidate shall be liable for disqualification from the process of selection and appropriate legal action will be taken. The decision taken by the Competent Authority in this respect shall be final and binding.

- 17.3 The student while studying in the Health Sciences Courses, if found indulging in antinational activities, unlawful activities or ragging in any form, contrary to the provisions of relevant Acts and Law enforced by Government, will be liable to be expelled from the college by the Dean/Principal of the College.
- 17.4 Pursuant to orders in W.P. (Civil) No. 656 of 1999, Hon'ble Supreme Court of India, has directed the Department of Human resources Development and Education, Govt. of India, to take all necessary steps to curb the menace of ragging and take severe action against the students involved in such activities.
- 17.5 As per the provisions of Maharashtra Act XXXIII known as "**Maharashtra Prohibition of ragging Act of 1999**", students indulging in ragging can be punished under the Act resulting in suspension, expulsion from the college and imprisonment.

18) PENALTY:

The allotment of social responsibility service will be implemented by Directorate of Medical Education Research, Mumbai and Directorate of Health Services, Government of Maharashtra.

16. PENALTY:

16.1 PENALTY FOR LAPSE OF SEAT (MBBS/BDS COURSES): Any candidate responsible for lapse of MBBS/BDS seat at **Government/Government Aided/Corporation** Medical/Dental College will have to pay a Non-Refundable penalty of Rs.10,00,000/- (Rupee Ten Lacs Only). This penalty is applicable to all those candidates who do not join during last round or cancel a seat after last round of admission. This penalty is also applicable to any candidate resigning a seat after cut off date for MBBS/BDS courses or also fails to complete the course, irrespective of admission quota of the candidate.

16.2 Penalty for Lapse of seat at Government/Government Aided/Private unaided College (Ayush Course): Any candidate who resigns a seat after cut off date from Government/Government Aided/Private unaided College (Ayush Course) will have to pay Rs. 3,00,000/- (Rs. Three lakhs only) as penalty.

16.3 Penalty for Lapse of seat at Government/Government Aided/Private unaided College (BNYS, BPTTh, BOTTh, BASLP & BP & O Courses): Any candidate who resigns a seat after cut off date from Government/Government Aided/Private unaided College (Allied Health Sciences courses) will have to pay Rs. 2,00,000/- (Rs. Two lakhs only) as penalty which will include 1st year tuition fees. If the candidate has paid the tuition fees to the institute, he/she will have to pay the difference amount only. If the candidate has not paid the tuition fees, he/she will have to pay Rs. 2,00,000/- (Rs. Two lakhs only).
