This is to inform that the Board of Governors considered the matter with regard to conversion of Diploma Seats into corresponding Degree seats from the academic year 2020-21 along with the request of the institute received through Central Govt. after notification dated 12/07/2018 as well as the recommendations of the PG Expert Group (BoG) on the basis of information furnished by the institute(s) as desired by the Council and decided to recommend to the Central Government for conversion of the postgraduate diploma course seats into corresponding degree seats prospectively i.e. from the academic session 2020-2021. (As per the list attached)

The permission to convert postgraduate diploma seat(s) to degree seats is subject to affiliation of additional PG degree seats by the concerned University.

The Institutes are required to obtain the affiliation from the concerned affiliating University with regard to above enhanced intake capacity of the degree courses before admitting the students.

In view of above, you are requested to issue Notification/ letter recognizing the above mentioned degree seats for the purpose of inclusion in the first schedule of the IMC Act, 1956 as is done in respect of recognition cases against increase of degree seats.

The Ministry is further requested that while issuing the Notification/ letter of recognition as stated above, it may be clearly stated that the said recognition was granted to degree seats created by way of surrender and conversion of diploma seats, so that the confusion as regard to timeline of recognition of degree seats is avoided.

In this regard, it is informed that the aforesaid Compliance Report was considered by the Post Graduate Medical Education Board (PGMEB) and based on the reply furnished by the college/ institute, approval of the PGMEB is hereby accorded in terms of Section 25(i) and 35(4) of NMC Act, 2019, for grant of Recognition against increased intake of MD(Paediatrics) qualification for 03 to 07 seats in respect of students being trained at Dr. Vaishampayan Memorial Government Medical College, Solapur under Maharashtra University of Health Sciences, Nashik, Maharashtra, under the following terms and conditions, as contained in the Post Graduate Medical Education Regulations, 2000:

- The recognition so being granted herein, shall be valid for a maximum (i) period of 05 (five) years from the year 2022, upon which it shall have to be renewed.
- The procedure for 'Renewal of Recognition' shall be same as applicable for (ii) the award of recognition.

- (iii) Failure to seek timely renewal of recognition as required in sub-clause (i) supra shall invariably result in stoppage of admissions to the concerned Post Graduate Course of the said institute.
- 2. The approval for Recognition against increased intake of MD(Paediatrics) qualification for 03 to 07 seats is granted subject to applicability of amendments in NMC Regulations from time to time.
